Green City Force (GCF) Corps Members are young residents of public housing who provide unique value to thousands of their fellow community members through innovative service projects, while gaining skills and experience on a path to careers. GCF's core service activities relate to sustainability in public housing, through community engagement tied to behavior change education (energy conservation, recycling...), as well as land improvement building and maintaining urban farms. Corps Members are under- or unemployed young adults, residents of public housing, with a GED or High School Diploma but lacking a clear path towards family-supporting careers. Through GCF's AmeriCorps service and training program and ongoing alumni initiatives, members gain skills, develop a passion, problem-solve complex issues in high-need communities, help meet city sustainability goals and gain training, certifications and work experience. GCF provides ongoing support services to Corps Members and alumni. On average, 80% of members graduate and 80% are working or in school.
